Application Information

Social Security Number – The use of Social Security number is voluntary. If you do not wish to have your Social Security number used for identification and record-keeping purposes, SUNY Empire State College will assign a student identification number.

Education – To be considered for graduate study, you must have earned a bachelor's degree and provide an official undergraduate transcript. To obtain an official transcript, send the registrar of the college or university where you received your bachelor's degree a transcript request. New York State Resident – If your principal or permanent home has not been located in New York state for a year prior to the date of enrollment for which this application is being made, you will be presumed to be an out-of-state resident, unless you provide documentation that you are making New York state your permanent residence. New York state residents who are not U.S. citizens must provide a copy of their permanent resident card (Form I-551).

Promoting Diversity – Empire State College and the State University of New York seek to enroll students of diverse racial and ethnic heritage. Racial and ethnic information is collected to meet federal reporting requirements.

Felony/Dismissal Information – A felony in New York state law is defined as a crime for which more than one year in prison may be imposed.
